You are further advised to note the following:

- 1. Your institution will be required to complete and submit to kasneb on an annual basis, a self-evaluation form (Form KAS/FM/ACC/006) together with all relevant supporting documents on or before the anniversary date of the institution's accreditation. The form is available for download from the kasneb website www.kasneb.or.ke.
- 2. Follow up visits will be undertaken by kasneb officers to your institution to confirm whether the standards of training are being consistently maintained at high levels.
- 3. An application for renewal of accreditation shall be made at least **ninety (90) days** before the date of expiry of the certificate of accreditation.
- 4. The certificate shall be prominently displayed at the premises of the institution at all times unless it is revoked or otherwise withdrawn in which case it shall be surrendered to kasneb within **fourteen (14) days** of its revocation or withdrawal.
- 5. kasneb shall maintain a register of accredited institutions which will be published from time to time through the kasneb website and other media as may be deemed fit.
- 6. This accreditation is not transferable and does not apply to any branches or campuses associated with the institution.
- 7. Any institution that continues to offer training for kasneb courses without a valid accreditation by kasneb will be in contravention of Section 17 of the Accountants Act., No. 15 of 2008.
